1. General

- 1.2 We reserve the right to update these Terms at any time. Any changes will be posted on this page with an updated effective date.

2. Purchases & Payments

- 2.1 All payments are processed through secure third-party gateways. By purchasing, you agree to pay all charges associated with your order.
- 2.2 Prices are correct at the time of purchase. TTC reserves the right to amend pricing at any time, but this will not affect completed purchases.
- 2.3 Digital products are delivered immediately after purchase via email download and/or access through your TTC account.

3. Refunds & Cancellations
